

DC Appleseed honors and appreciates the exceptional service of Nick Fels. Since helping to found the organization in 1994 until his retirement in 2022, Nick Fels served with excellence on DC Appleseed's board. From 1997 through 1999, Nick lead the organization as Chair of DC Appleseed's Board of Directors.

A graduate of Harvard (B.A. 1964, J.D. 1968) and the University of California at Berkeley (M.A. 1965), Nick clerked on the U.S. Court of Appeals for the Fifth Circuit for Judge John Minor Wisdom. He worked as a legal aid lawyer in Alhambra, California before moving to Washington and joining Covington & Burling in 1970, where he practiced until his retirement in 2008, specializing in the field of utility regulation.

Nick's involvement in public service goes back to the summer of 1964, when he worked as a teacher at a "Freedom School" in Hattiesburg, Mississippi. In addition to DC Appleseed, he has served on the boards of several non-profits, and, with past DC Appleseed board chair Richard Herzog, has also worked pro bono on climate-change issues for various environmental organizations.

Nick and his wife, Susan, were married in 1968. Their daughter Sarah and her husband George live in New York with their two children, Anna (18) and Alexander (14).
